Notes

- **Sections of the register.** The register is published in four sections: 1 - currently registered contractors, 2 - currently registered practitioners, 3 - formerly registered, now expired contractors, 4 - formerly registered, now expired practitioners.
- **Building engineering contractors and practitioners.** A building engineering contractor is authorised to contract to provide building engineering services to others. A building engineering practitioner is entitled to be appointed as the nominated supervisor to a building engineering contractor, but may not personally contract to provide building engineering services to others. Each contractor is required to have appointed at least one nominated supervisor.
- **Professional, Technologist and Associate.** Building engineering practitioners are registered by area (civil, structural, mechanical, fire safety) and level (professional, technologist, associate). Building engineering contractors are registered at either professional, technologist, associate, fire systems - technologist or fire systems - associate level. A professional contractor can perform professional and technical engineering work on all buildings, unless restricted by a specific condition placed on the contractor's registration. A technologist contractor can perform technical engineering work for medium rise buildings, unless further limited by a specific condition placed on the contractor's registration. An associate contractor can perform technical engineering work for low rise buildings, unless further limited by a specific condition placed on the contractor's registration. A fire systems - technologist can perform technical fire systems engineering work for all buildings, unless further limited by a specific condition placed on the contractor's registration. A fire systems associate can perform technical fire systems engineering work for medium rise buildings, unless further limited by a specific condition placed on the contractor's registration. A building engineering contractor have arrangements in place to ensure that all building engineering work it contracts to provide is managed and supervised by appropriately registered building engineering practitioners.
- **Conditions on a registration.** The Building Services Board can place conditions on a contractor's or a practitioner's registration. When the Board has applied conditions, the conditions will be shown under the contractor's or practitioner's name.
- **Reg No.** BEC for building engineering contractors and BEP for building engineering practitioners. Acronyms form part of the registration number.
